- New Board member list was sent out
- RHS contact and rate, Additions to Nancy's position Devere Hunt Badger Inc (RHS) In the June Board meeting Badger Inc will present a new contract between Center for Hope and Badger inc for executive director services. The former contract has been in place since 2018 and needs updating to current practices between the Center for Hope and Badger Inc. To also include all employees. Badger Inc. is also going to sign a contract for executive director services with the Hope and Recovery Resource Center Board in Pocatello. Their executive director is retiring . Nancy Espeseth will become regional director 1/2 time with Hope and Recovery Resource Center and 1/2 time with Center for Hope and there will be an additional assistant director position to cover the remainder of Nancy's responsibilities. Two recovery coaches at the Center for Hope, Grace and Donna are a possibility to take that position. This is an effort by Badger Inc to expand Nancy's recovery center vision to an additional region and create a collaborative effort with the recovery center in Pocatello. The Hope and Recovery Resource Center also has rural satellite physical offices in soda springs and Nancy is interested in learning from this pattern to eventually, if possible or needed, with the approval of the board, open physical offices in more rural areas. The Center for Hope and Hope and Recovery Resource Center will remain two separate nonprofits with their own governing boards. A goal is to create a partnership between the Hope and Recovery Center in Pocatello and the Pocatello crisis South Eastern Idaho Behavioral Crisis Center similar to how Center for Hope partners with BHCC. Executive Director services for Center for Hope will remain consistent and present with Badger Inc management while Nancy and an additional assistant director reform their responsibilities.
